AMENDED CERTIFICATE OF LOCATION
LODE MINING CLAIM

This document corrects the original certificate of location and amended certificate of location as filed in Eureka County, document number 209750 at Book 458, Page 127 (original), document number 220251 at Book 531, Page 38 (amended), and with the Nevada BLM (NMC954500). This document is being filed to correct the tie to an established public survey monument.

NOTICE IS HEREBY GIVEN by Richard McKay, Pamela S. Scutt and Nancy Minoletti, the current owners of the claim, whose addresses for purposes of this document are c/o Richard McKay, 2749 MiraBella Circle, Morgan Hill, California 95037, that the BUFF 43 lode mining claim, more particularly described below, was located on the 27th day of March, 2007.

The claim is approximately 1500 feet long and 600 feet wide, such that 200 feet are claimed in a North direction and 1300 feet in a South direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with 150 feet on each side of the monument of location and center line of the claim. The monument of location upon which the Notice of Location was posted is a wood post measuring at least 1½" x 1½" x 4', set one foot in the ground. The general course of the lode or vein is from the North to South direction.

The exterior boundaries of the claim are distinctly marked by four wooden posts measuring at least 1½" x 1½" x 4', set one foot in the ground, one at each corner. The boundaries of the claim are described as follows: Beginning at the NE corner (Cor. 1) of the claim, which is marked "NE 43", from which the SE corner of Section 36, Township 16 North, Range 52 East, M.D.B.&M. bears approximately 11642 feet East and 3200 feet North:

- thence 1500 feet South to the SE Corner (Cor. 2), which is marked "SE 43",
- thence 300 feet West to the SW Corner (Cor. 3), which is marked "SW 43/Side 18",
- thence 1500 feet North to the NW Corner (Cor. 4), which is marked "NW 43",
- thence 300 feet East to said Cor. 1, the point of beginning.

The corners were so marked on the posts by scribed metal tags.


The claim is located within the:

SE¼ of Section 3, T 15 N, R 52 E, M.D.B.&M., Eureka County, Nevada.

The boundaries of the claim were defined as required by law within 60 days from the date of posting of the Notice of Location. The work of location consisted of making the claim map as provided in N.R.S. § 517.040.
