## **AMENDED CERTIFICATE OF LOCATION** **LODE MINING CLAIM**

This document corrects the original certificate of location and amended certificate of location as filed in Eureka County, document number 209753 at Book 458, Page 130 (original), document number 220253 at Book 531, Page 40 (amended), and with the Nevada BLM (NMC954503). This document is being filed to correct the tie to an established public survey monument and to affirm the boundaries of the claim and appropriate the full extent of the ground described herein, in accordance with the provisions of NRS § 517.200.1.

NOTICE IS HEREBY GIVEN by Richard McKay, Pamela S. Scutt and Nancy Minoletti, the current owners of the claim, whose addresses for purposes of this document are c/o Richard McKay, 2749 MiraBella Circle, Morgan Hill, California 95037, that the **BUFF 46** lode mining claim, more particularly described below, was located on the 30<sup>th</sup> day of **April, 2007**.

The claim is approximately **1500 feet** long and **600 feet** wide, such that **20 feet** are claimed in an **East** direction and **1480 feet** in an **West** direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with **300 feet** on each side of the monument of location and center line of the claim. The monument of location upon which the Notice of Location was posted is a wood post measuring at least  $1\frac{1}{2}$ " x  $1\frac{1}{2}$ " x 4', set one foot in the ground. The general course of the lode or vein is from the **East to West** direction.

The exterior boundaries of the claim are distinctly marked by four wooden posts measuring at least  $1\frac{1}{2}$ " x  $1\frac{1}{2}$ " x 4', set one foot in the ground, one at each corner. The boundaries of the claim are described as follows: Beginning at the NE corner (Cor. 1) of the claim, which is marked "**NE 46**", from which the SE corner of Section 36, Township 16 North, Range 52 East, M.D.B.&M. bears approximately **9805 feet East** and **2700 feet North**:

thence **600 feet South** to the SE Corner (Cor. 2), which is marked "**SE 46**",

thence **1500 feet West** to the SW Corner (Cor. 3), which is marked "**SE 45/SW 46**",

thence **600 feet North** to the NW Corner (Cor. 4), which is marked "**SE 47/NE 45/NW 46**",

thence **1500 feet East** to said Cor. 1, the point of beginning.

The corners were so marked on the posts by scribed metal tags.

The claim is located within the: **SE¼ of Section 3, T 15 N, R 52 E, and SW¼ of Section 2, T 15 N, R 52 E**  
M.D.B.&M., Eureka County, Nevada.

The boundaries of the claim were defined as required by law within 60 days from the date of posting of the Notice of Location. The work of location consisted of making the claim map as provided in N.R.S. § 517.040.
