AMENDED CERTIFICATE OF LOCATION
LODE MINING CLAIM

This document amends the original certificate of location and amended certificate of location as filed in Eureka County, document number 204761 at Book 436, Page 133 (original) and document number 220261 at Book 531, Page 48 (amended), and with the Nevada BLM (NMC926069). This document corrects the tie to an established public survey monument.

NOTICE IS HEREBY GIVEN that AMERICAN VANADIUM US INC., a Nevada corporation whose address is P.O. Box 983 Eureka, Nevada, 89316 located the **DAN 7** lode mining claim, more particularly described below, on the 5th day of **March, 2006**.

The claim is approximately **1500** feet long and **600** feet wide, such that **10** feet are claimed in an **Easterly** direction and **1490** feet in a **Westerly** direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with **300** feet on each side of the monument of location and center line of the claim. The monument of location upon which the Notice of Location was posted is a wood post measuring at least $1\frac{1}{2}$ " x $1\frac{1}{2}$ " x 4', set one foot in the ground. The general course of the lode or vein is from the **Easterly** to **Westerly** direction.

The exterior boundaries of the claim are distinctly marked by four wooden posts measuring at least $1\frac{1}{2}$ " x $1\frac{1}{2}$ " x 4', set one foot in the ground, one at each corner. The boundaries of the claim are described as follows: Beginning at the NE corner (Cor. 1) of the claim, which is marked "**NE Cor. DAN 7**", from which the SE corner of Section 36, Township 16 North, Range 52 East, M.D.B.&M. bears approximately **11,389 feet East** and **1,442 feet North**:

thence **600 feet South** to the SE Corner (Cor. 2), which is marked "**SE Cor. DAN 7**",
thence **1500 feet West** to the SW Corner (Cor. 3), which is marked "**SW Cor. DAN 7**",
thence **600 feet North** to the NW Corner (Cor. 4), which is marked "**NW Cor. DAN 7**",
thence **1500 feet East** to said Cor. 1, the point of beginning.

The corners were so marked on the posts by scribed metal tags.

The claim is located within the:


NE $\frac{1}{4}$ of Section 3, T 15 N, R 52 E, M.D.B.&M., Eureka County, Nevada.
