**AMENDED CERTIFICATE OF LOCATION**  
**LODE MINING CLAIM**

This document amends the original certificate of location and amended certificate of location as filed in Eureka County, document number 204772 at Book 436, Page 144 (original) and document number 220269 at Book 531, Page 56 (amended), and with the Nevada BLM (NMC926080). This document corrects the tie to an established public survey monument.

NOTICE IS HEREBY GIVEN that AMERICAN VANADIUM US INC., a Nevada corporation whose address is P.O. Box 983 Eureka, Nevada, 89316 located the DAN 18 lode mining claim, more particularly described below, on the 6<sup>th</sup> day of March, 2006.

The claim is approximately 1500 feet long and 400 feet wide, such that 10 feet are claimed in an N 10° E direction and 1490 feet in an S 10° W direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with 200 feet on each side of the monument of location and center line of the claim. The monument of location upon which the Notice of Location was posted is a wood post measuring at least 1½" x 1½" x 4', set one foot in the ground. The general course of the lode or vein is from the N 10° E to the S 10° W direction.

The exterior boundaries of the claim are distinctly marked by four wooden posts measuring at least 1½" x 1½" x 4', set one foot in the ground, one at each corner. The boundaries of the claim are described as follows: Beginning at the NE corner (Cor. 1) of the claim, which is marked "NE Cor. DAN 18", from which the SE corner of Section 36, Township 16 North, Range 52 East, M.D.B.&M. bears approximately 7,647 feet East and 3,173 feet South:

thence 1500 feet S 10° W to the SE Corner (Cor. 2), which is marked "SE Cor. DAN 18",  
thence 400 feet N 80° W to the SW Corner (Cor. 3), which is marked "SW Cor. DAN 18",  
thence 1500 feet N 10° E to the NW Corner (Cor. 4), which is marked "NW Cor. DAN 18",  
thence 400 feet S 80° E to said Cor. 1, the point of beginning.

The corners were so marked on the posts by scribed metal tags.

The claim is located within the:

NE¼ of Section 35, T 16 N, R 52 E, NW¼ of Section 35, T 16 N, R 52 E, SE¼ of Section 35, T 16 N, R 52 E, and SW¼ of Section 35, T 16 N, R 52 E, M.D.B.&M., Eureka County, Nevada.

The boundaries of the claim were defined as required by law within 60 days from the date of posting of the Notice of Location. The work of location consisted of making the claim map as provided in N.R.S. § 517.040.
