## AMENDED CERTIFICATE OF LOCATION LODE MINING CLAIM

This document corrects the certificate of location as filed in Eureka County, document number 219284 at Book 526, Page 382, and with the Nevada BLM (NMC1062065). This document is being filed to correct the tie to an established public survey monument.

NOTICE IS HEREBY GIVEN that AMERICAN VANADIUM US INC., a Nevada corporation whose mailing address is P.O. Box 983, Eureka, Nevada 89316, located the FLOW 7 lode mining claim, more particularly described below, on the 3rd day of December, 2011.

The claim is approximately 1500 feet long and 600 feet wide, such that 20 feet are claimed in a N 46°43' E direction and 1480 feet in a S 46°43' W direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with 300 feet on each side of the monument of location and center line of the claim. The monument of location upon which the Notice of Location was posted is a wood post measuring at least 1½" x 1½" x 4', set one foot in the ground. The general course of the lode or vein is from the Northeasterly to the Southwesterly direction.

The exterior boundaries of the claim are distinctly marked by four wooden posts measuring at least 1½" x 1½" x 4', set one foot in the ground, one at each corner. The boundaries of the claim are described as follows: Beginning at the NE corner (Cor. 1) of the claim, which is marked "Flow 7 North Cor.," from which the SE corner of Section 36, Township 16 North, Range 52 East, M.D.B.&M. bears approximately 6,547 feet North and 2,655 feet West: thence 600 feet S 43°30' E to the SE Corner (Cor. 2), which is marked "Flow 7 East Cor.," thence 1500 feet S 46°43' W to the SW Corner (Cor. 3), which is marked "Flow 7 South Cor.," thence 600 feet N 43°30' W to the NW Corner (Cor. 4), which is marked "Flow 7 West Cor.," thence 1500 feet N 46°43' E to said Cor. 1, the point of beginning.

The corners were so marked on the posts by scribed metal tags.

The claim is located within the:

NE¼ of Section 7, Township 15 North, Range 53 East


NW¼ of Section 7, Township 15 North, Range 53 East

SW¼ of Section 7, Township 15 North, Range 53 East; M.D.B.&M., Eureka County, Nevada.

The boundaries of the claim were defined as required by law within 60 days from the date of posting of the Notice of Location. The work of location consisted of making the claim map as provided in N.R.S. § 517.040.
