**AMENDED CERTIFICATE OF LOCATION**  
**LODE MINING CLAIM**

This document corrects the certificate of location as filed in Eureka County, document number 217054 at Book 514, Page 59, and with the Nevada BLM (NMC1042073). This document is being filed to correct the tie to an established public survey monument.

NOTICE IS HEREBY GIVEN that AMERICAN VANADIUM US INC., a Nevada Corporation whose mailing address is P.O. Box 983, Eureka, Nevada, 89316, located the Jct. No. 1 lode mining claim, more particularly described below, on the 30<sup>th</sup> day of March, 2011.

The claim is approximately 1,500 feet long and 600 feet wide, such that 35 feet are claimed in a N 13° 0' 0" E direction and 1465 feet in a S 13° 0' 0" W direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with 300 feet on each side of the monument of location and center line of the claim. The monument of location upon which the Notice of Location was posted is a wood post measuring at least 1½" x 1½" x 4', set one foot in the ground. The general course of the lode or vein is from the Northeasterly to Southwesterly direction.

The exterior boundaries of the claim are distinctly marked by four wooden posts measuring at least 1½" x 1½" x 4', set one foot in the ground, one at each corner. The boundaries of the claim are described as follows: Beginning at the NW corner of the claim, which is marked NW Cor. Jct. No. 1, from which the protracted NW corner of Section 13, Township 16 North, Range 53 East, MDM bears approximately N 62° 0' 0" W a distance of 1775 feet:  
thence 600 feet S 77° 0' 0" E to the NE Corner, which is marked NE Cor. Jct. No. 1,  
thence 1500 feet S 13° 0' 0" W to the SE Corner, which is marked SE Cor. Jct. No. 1,  
thence 600 feet N 77° 0' 0" W to the SW Corner, which is marked SW Cor. Jct. No. 1,  
thence 1500 feet N 13° 0' 0" E to said NW Cor. Jct. No. 1, the point of beginning.

The corners were so marked on the posts with black ink, or were marked on a scribed aluminum tag attached to the post.


The claim is located within the:

NW¼ quarter of Section 13, Township 16 North, Range 53 East; M.D.B.&M., Eureka County, Nevada.

The boundaries of the claim were defined as required by law within 60 days from the date of posting of the Notice of Location. The work of location consisted of making the claim map as provided in N.R.S. § 517.040.
