**AMENDED CERTIFICATE OF LOCATION**  
**LODE MINING CLAIM**

This document corrects the certificate of location as filed in Eureka County, document number 219274 at Book 526, Page 373, and with the Nevada BLM (NMC1062056). This document is being filed to correct the tie to an established public survey monument.

NOTICE IS HEREBY GIVEN that AMERICAN VANADIUM US INC., a Nevada corporation whose mailing address is P.O. Box 983, Eureka, Nevada 89316, located the MATT 16 lode mining claim, more particularly described below, on the 29th day of September, 2011.

The claim is approximately 1500 feet long and 600 feet wide, such that 1450 feet are claimed in a North direction and 50 feet in a South direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with 300 feet on each side of the monument of location and center line of the claim. The monument of location upon which the Notice of Location was posted is a wood post measuring at least 1½" x 1½" x 4", set one foot in the ground. The general course of the lode or vein is from the South to North direction.

The exterior boundaries of the claim are distinctly marked by four wooden posts measuring at least 1½" x 1½" x 4", set one foot in the ground, one at each corner. The boundaries of the claim are described as follows: Beginning at the SW corner (Cor. 1) of the claim, which is marked "MATT 16 SW Cor.", from which the SE corner of Section 36, Township 16 North, Range 5, East, M.D.B.&M. bears approximately 1077 feet South and 1797 feet East:

thence 1500 feet North to the NW Corner (Cor. 2), which is marked "MATT 16 NW Cor.",  
thence 600 feet East to the NE Corner (Cor. 3), which is marked "MATT 16 NE Cor.",  
thence 1500 feet South to the SE Corner (Cor. 4), which is marked "MATT 16 SE Cor.",  
thence 600 feet West to said Cor. 1, the point of beginning.

The corners were so marked on the posts by scribed metal tags.

The claim is located within the:


SE¼ of Section 36, Township 16 North, Range 52 East
