ASSIGNMENT AGREEMENT

Pathfinder Mines Corporation ("Assignor"), a Delaware corporation, and AREVA NC Inc. ("Assignee"), a Delaware corporation, for valuable consideration, hereby agree as follows, effective as of May 30, 2013 (the "Effective Date"):

1. As of the Effective Date, Assignor assigns, transfers, quitclaims, conveys and delegates to Assignee all of Assignor's right, title, duties, liabilities, obligations and interests in and to the royalties, and any other items, described in Exhibit A, attached hereto and hereby incorporated herein (the "Assigned Interests").
2. Assignor assigns, transfers, conveys and delegates the Assigned Interests to Assignee without any warranties or representations whatsoever, express or implied, and without indemnification by or recourse against Assignor, or any of its affiliates.
3. Assignee accepts and assumes assignment, transfer, quitclaim, conveyance and delegation of the Assigned Interests in accordance with the terms and conditions of this Assignment Agreement. Assignee agrees to indemnify, defend and hold harmless Assignor and its affiliates of and from any claims, demands, liabilities or obligations arising out of or with respect to the Assigned Interests after the Effective Date.
4. This Assignment Agreement sets forth the entire agreement between the parties hereto with respect to the subject matter hereof. This Assignment Agreement shall be binding upon and inure to the benefit of the parties and the respective successors and assigns of each. Any amendment or modification of this Assignment Agreement must be in writing, signed by the parties hereto. This Assignment Agreement shall be governed by and construed in accordance with the laws of the State of Wyoming, without reference to conflict of law provisions.



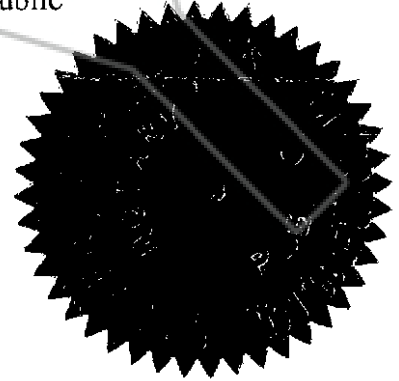
