Each corner monument consists of a 2" x 2" x 4' wooden post with aluminum tags attached, scribed with claim name and corner description, set one foot in the ground. 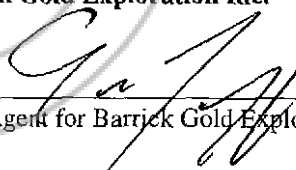
