The name of the claim is the MTB 361.

This claim was located on 10/28/2013, by posting a Location Notice at the discovery monument.

The length of the claim is 10 feet in a East direction and 1490 feet in the opposite direction from
the monument where the Location Notice is posted, and the width is 300 feet on each side of the center of the
