CERTIFICATE OF LOCATION

United States of America the following described LODE MINING CLAIM:

The name of the claim is the MTB 368.

This claim was located on 10/28/2013, by posting a Location Notice at the discovery monument.

The length of the claim is 1490 feet in a East direction and 10 feet in the opposite direction from
the monument where the Location Notice is posted, and the width is 300 feet on each side of the center of the
vein or lode, comprising in all 1500 feet in length and 600 feet in width, and generally following a Easterly-
Westerly course.
