That the Trustees by the terms of the Trust are given the full power of investment of the Trust Estate, without the necessity of the supervision of any court; authorization to keep any or all securities, real property or other properties constituting a part or all of the Trust property in the name or names of Trustees, without disclosing their fiduciary capacity; or to hold securities in the name of a nominee;

together with all of the powers provided to Trustees by Nevada Revised Statutes, Sections 163.260 through 163.410, inclusive and all powers confirmed by law.

6. That the identifying number of the trust is the Social Security Number of the Trustee, RICHARD E. KEPHART, i.e.,
7. That the form in which title to assets of the trust is taken is the "R.E. AND M. A. KEPHART FAMILY TRUST."

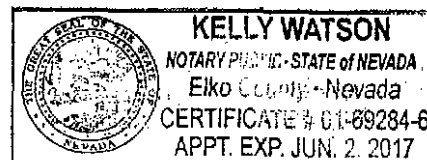
