4. If RICHARD E. KEPHART shall for any reason cease to act as Trustee, MARI ALICE KEPHART shall act as sole Trustee. If MARI ALICE KEPHART shall for any reason cease to act as Trustee, RICHARD E. KEPHART shall act as sole Trustee. If both RICHARD E. KEPHART and MARI ALICE KEPHART shall for any reason cease to act as Trustee, the Trustors' child, SUSAN ELAINE FINNERTY, shall serve as successor Trustee
5. That the Trustees by the terms of the Trust are given the full power of investment of the Trust Estate, without the necessity of the supervision of any court; authorization to keep any or all securities, real property or other properties constituting a part or all of the Trust property in the name or names of Trustees, without disclosing their fiduciary capacity; or to hold securities in the name of a nominee;

together with all of the powers provided to Trustees by Nevada Revised Statutes, Sections 163.260 through 163.410, inclusive and all powers confirmed by law.


6. That the identifying number of the trust is the Social Security Number of the Trustee, RICHARD E. KEPHART, i.e.,


