STIPULATION OF JUDGMENT AND

<u>ORDER</u>

Defendant(s), Kimberly Ann Walls, above named admits that they are indebted to Plaintiff for \$14338.15, all court costs in the amount of \$275.00, for a total sum of \$14,613.15. No part of this original debt has been paid by Defendant(s), and that amount is now justly and presently due from Defendant(s) to Plaintiff. Defendant's indebtedness is the subject of the action captioned above. Plaintiff and Defendant(s) desire to settle this matter and, after being given the opportunity to consult with counsel, agree as follows:

Plaintiff may take judgment against the Defendant(s) pursuant to the terms set forth Below:

- 1. Pursuant to NRS 17.130(2), this judgment shall accrue interest at the legal rate (currently 5.25%, but adjusted each January 1 and July 1) per year, only upon event of default, from the date of service of the Summons and Complaint, which was on November 1, 2013, until satisfied.
- 2. Defendant(s) will make a down payment in the amount of \$500.00 due by February 25, 2014;
- 3. Thereafter, Defendant(s) will make consecutive monthly installment payments to Plaintiff

in the amount of \$355.00 for 23 months, and one final month of \$335.00;

- 4. Payments described in paragraph no. 2 above shall commence on February 25, 2014 and shall be due on the 25th day of each subsequent month thereafter until the settlement balance of \$9,000.00 is paid completely, and at which time Plaintiff will file a satisfaction of judgment if the balance of \$9,000.00 is paid without default;

- 8. Plaintiff agrees there shall be one month of late payment forgiveness, in which the default provisions of this agreement shall not activate;

 Defendant(s) shall become liable to Plaintiff for any additional attorney's fees and court costs
