OMNIBUS AMENDMENT TO DEEDS OF TRUST, MORTGAGES, SECURITY AGREEMENTS, FIXTURE FILINGS AND FINANCING STATEMENTS $\mu\nu\nu$

This OMNIBUS AMENDMENT TO DEEDS OF TRUST, MORTGAGES, SECURITY AGREEMENTS, FIXTURE FILINGS AND FINANCING STATEMENTS (this "Amendment") is entered into as of April 30, 2014 (the "Effective Date") by Berry Petroleum Company, LLC (formerly known as Berry Petroleum Company), a Delaware limited liability company (the "Mortgagor"), and Wells Fargo Bank, N.A., as Administrative Agent (the "Mortgagee").

RECITALS:

- A. The Mortgagor, as borrower, the financial institutions from time to time party thereto (the "Lenders") and Mortgagee, as administrative agent for the Lenders, entered into a Second Amended and Restated Credit Agreement dated as of November 15, 2010, (as amended, supplemented or restated to the date hereof, the "Credit Agreement"), pursuant to which, upon the terms and conditions stated therein, the Lenders have agreed to make loans and other extensions of credit to Mortgagor.
- B. The Credit Agreement is secured by, among other things, that certain Deed of Trust, Assignment, Security Agreement, Fixture Filing and Financing Statement dated as of July 15, 2008, from Mortgagor to Mortgagee, as amended by that certain First Supplement and Amendment dated as of April 1, 2010, that certain Second Supplement and Amendment dated as November 15, 2010, that certain Third Supplement and Amendment dated as of April 14, 2011 and that certain Fourth Supplement and Amendment dated as of November 21, 2013, and recorded in the offices designated for the filing of a record of mortgage in the jurisdictions set forth in Annex I hereto (as amended, the "Texas Deeds of Trust").
- C. The Credit Agreement is further secured by, among other things, that certain Mortgage, Assignment, Security Agreement, Fixture Filing and Financing Statement dated as of November 15, 2010, from Mortgagor to Mortgagee, and recorded in the offices designated for the filing of a record of mortgage in the jurisdiction set forth in Annex II hereto (as amended, the "Colorado Mortgage").
- D. The Credit Agreement is further secured by, among other things, that certain Deed of Trust, Assignment, Security Agreement, Fixture Filing and Financing Statement dated as of July 15, 2008, as amended by that certain First Supplement and Amendment dated as of November 15, 2010, from Mortgagor to Mortgagee, and recorded in the offices designated for the filing of a record of mortgage in the jurisdiction set forth in Annex III hereto (as amended, the "Utah Deed of Trust").

- E. The Credit Agreement is further secured by, among other things, that certain Deed of Trust, Assignment, Security Agreement, Fixture Filing and Financing Statement dated as of April 1, 2010, as amended by that certain First Supplement and Amendment dated as of December 10, 2010, from Mortgagor to Mortgagee, and recorded in the offices designated for the filing of a record of mortgage in the jurisdictions set forth in Annex IV hereto (as amended, the "Nevada Deeds of Trust").
- F. The Texas Deeds of Trust, the Colorado Mortgage, the Utah Deed of Trust and the Nevada Deeds of Trust are collectively referred to herein as the "Mortgages."
 - G. The Mortgagor and Mortgagee desire to amend the Mortgages as set forth therein.
- H. Therefore, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and in consideration of the loans, extensions of credit and commitments referred to in the Credit Agreement, the Mortgagor and Mortgagee hereby agree as follows:

Section 1.01 Defined Terms.

- (a) Each capitalized term used and not defined herein has the meaning assigned such term in the Mortgages, and all uncapitalized terms which are defined in the UCC are used herein as so defined. As used herein, "UCC" means the Uniform Commercial Code presently in effect in the State of Texas, State of Colorado and State of Utah, as applicable, as the same may be amended from time to time.
- (b) All references in the Mortgages to "this Mortgage" or "this Deed of Trust", as defined in the Mortgages shall mean the Mortgages as amended and supplemented and as the same may from time to time be further amended or supplemented.

Section 1.02 Amendment.

- (a) Section 1.4(b) of the Mortgages is amended to replace the phrase "November 13, 2015" with "April 6, 2019".
- Section 1.03 <u>Confirmation</u>. The Mortgages are hereby ratified, restated, adopted, confirmed, and renewed, except to the extent of any releases in writing by the Agent, or its predecessor, which were delivered to Mortgagor prior to the date hereof.
- Section 1.04 <u>Miscellaneous</u>; <u>Representations and Warranties</u>. This Amendment is a "Loan Document" as defined and described in the Credit Agreement and is effective as a Financing Statement and Fixture Filing and described in the Mortgages. Each Mortgagor hereby acknowledges and agrees that except as specifically amended, supplemented, changed or modified hereby, the Mortgage shall remain in full force and effect in accordance with its terms. None of the rights, titles and interests existing and to exist under the Mortgage are hereby released, diminished or impaired, and each Mortgagor hereby reaffirms all covenants, representations and warranties made in the Mortgage.

Section 1.05 Governing Law. Insofar as permitted by otherwise applicable law, this Amendment shall be construed under and governed by the laws of the State of Texas (excluding choice of law and conflict of law rules); provided, however, that, with respect to any portion of the Mortgaged Property located outside of the State of Texas, the laws of the place in which such Property is located in, or offshore adjacent to (and State law made applicable as a matter of Federal law), shall apply to the extent of procedural and substantive matters relating only to the creation, perfection, foreclosure of Liens and enforcement of rights and remedies against the Mortgaged Property.

Section 1.06 <u>Counterparts</u>. This Amendment is being executed in several counterparts, all of which are identical. Each of such counterparts shall for all purposes be deemed to be an original and all such counterparts shall together constitute but one and the same instrument.




