**MEMORANDUM OF GEOTHERMAL LEASE AND NOTICE OF  
NONRESPONSIBILITY**

Notice is given that Henry Filippini, acting as agent pursuant to the Will of Dan Filippini, deceased, Frome Minerals, LLC a Wyoming limited liability company, and representatives of Doyle Child, hereinafter referred to as "Lessor", and U.S. Geothermal Inc. ("USG"), an Idaho corporation, hereinafter referred to as "Lessee"; have entered into a Geothermal Lease, (herein referred to as "Lease") made and entered into the 1<sup>st</sup> day of June, 2014. The primary term of the Lease is forty years and expires on the 1<sup>st</sup> day of June, 2054 unless, in accordance with the Lease terms, commercial operation of the geothermal field is achieved then the lease will remain in effect for the duration of commercial operations. Lessor and USG may assign their respective interest in and under the Lease.

The Lessor has no interest in the improvement or the surface upon which the improvement is or will be constructed, altered or repaired.

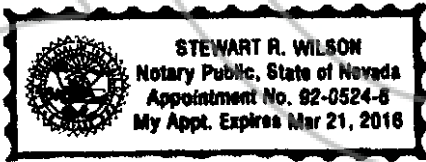
