### MEMORANDUM OF RIGHT OF WAY AND SURFACE FACILITIES AGREEMENT

In consideration of the sum of One Dollar (\$1.00) and other valuable consideration, the adequacy and receipt of which are hereby acknowledged, NEWMONT USA LIMITED, a Delaware corporation and ELKO LAND AND LIVESTOCK COMPANY, hereinafter referred to as "Grantor," hereby grant an easement and right of way to and grant, lease, let and demise unto Prospector Pipeline Company, a Nevada corporation, hereinafter referred to as "Grantee" that certain property described on Exhibit "A" and shown on Exhibit "B" for Grantee's construction, ownership and, and operation of a natural gas pipeline for the purposes of conveying natural gas and use as surface facility sites in the county of Eureka, State of Nevada. This agreement is subject to the terms and conditions of that certain Right of Way and Surface Facilities Agreement is hereby incorporated by reference with the same force and effect as though herein set forth at length.

This Memorandum of Right of Way and Surface Facilities Agreement may be signed in multiple counterparts, all of which, taken together, shall constitute one single agreement. This agreement shall be binding upon all parties hereto, their heirs, successors and assigns.


