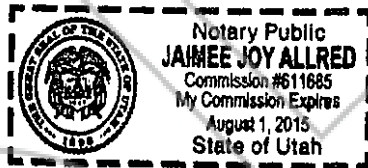

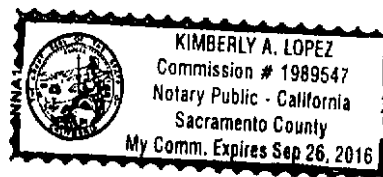

BARRICK GOLDSTRIKE MINES AS-BUILT
LEGAL DESCRIPTION
BEING A PORTION OF APN 004-030-19**

That certain land situated in Eureka County, Nevada, described as a surface facility known as the Barrick Goldstrike Mines Meter Station, as described below, and a permanent right-of-way (easement), identified as "Easement Area", measuring the uniform width of fifteen (15'), unless otherwise noted below, and lying seven and one-half feet (7 1/2') on each side of an existing gas pipeline, the centerline of which is described as follows:

**BARRICK GOLDSTRIKE MINES
METER STATION**

All that certain real property situate within a portion of the Northeast One-Quarter (NE 1/4) of Section Twenty-Nine (29), Township Thirty-Six (36) North, Range Fifty (50) East, Mount Diablo Meridian, Eureka County, Nevada, being a portion of APN 004-030-19, enclosed by a chain link fence encompassing a gas pipeline metering station, the perimeter of which being more particularly described as follows; and

COMMENCING from Nevada State Plane Coordinate (henceforth known as NSPC) North: 28513313.70 East: 448341.75, also being the angle point of an existing gas pipeline;
THENCE North 64°18'23" WEST a distance of 290.01 feet, more or less, to the northeasterly corner of said Meter Station, also being the **POINT OF BEGINNING**;
THENCE along the easterly line of said Metering Station, South 00°13'32" West a distance of 220.49 feet to the southeasterly corner of said Metering Station;
THENCE along the southerly line, South 84°48'03" West a distance of 102.54 feet to the southwesterly corner of said Meter Station;
THENCE along the westerly line, North 00°08'53" East a distance of 228.68 feet to the northwesterly corner of said Meter Station;
THENCE along the northerly line, North 89°23'06" East a distance of 102.40 feet to the **POINT OF BEGINNING**;

The sidelines of said Metering Station are to be prolonged or shortened so as to terminate at the perimeter of the fence as described;

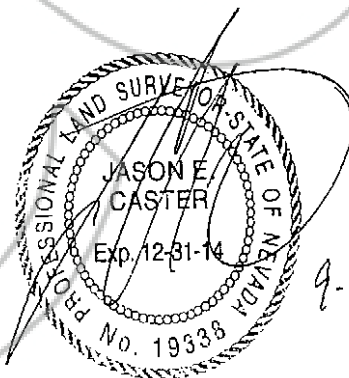
The sidelines of said easement are to be prolonged or shortened so as to terminate at the east and line of said Parcel, and perpendicular to the end of the pipeline.

The basis of bearings for this description was determined by Static GPS observations of on-site control constrained and adjusted to CORS stations in the surrounding area, and verified using the NGS OPUS website. Bearings and distances shown hereon are NAD 83/94, Nevada East 2701, State Plane Grid values. The property lines shown hereon are from a combination of Eureka County GIS linework and found monumentation in the area. In areas of found monuments, the GIS property lines were adjusted to match the PLSS lines.

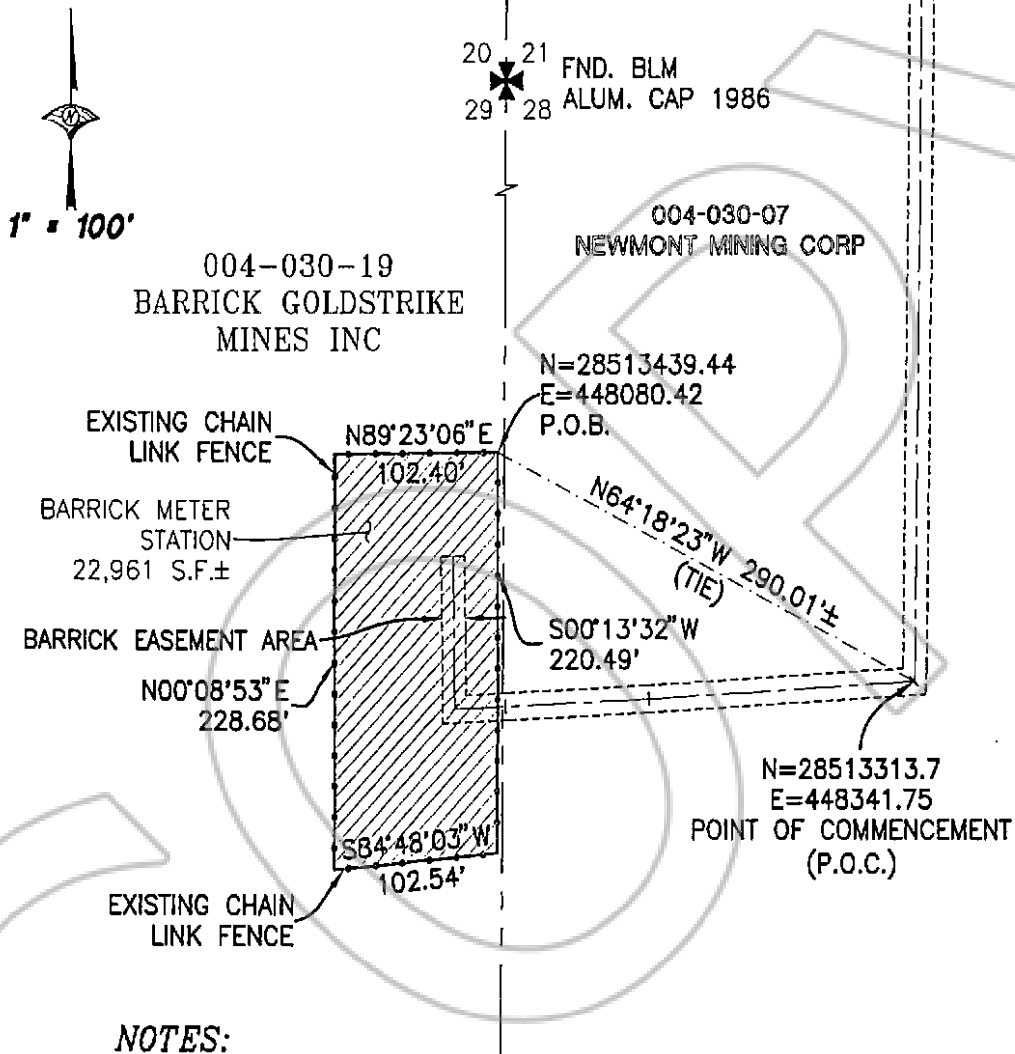

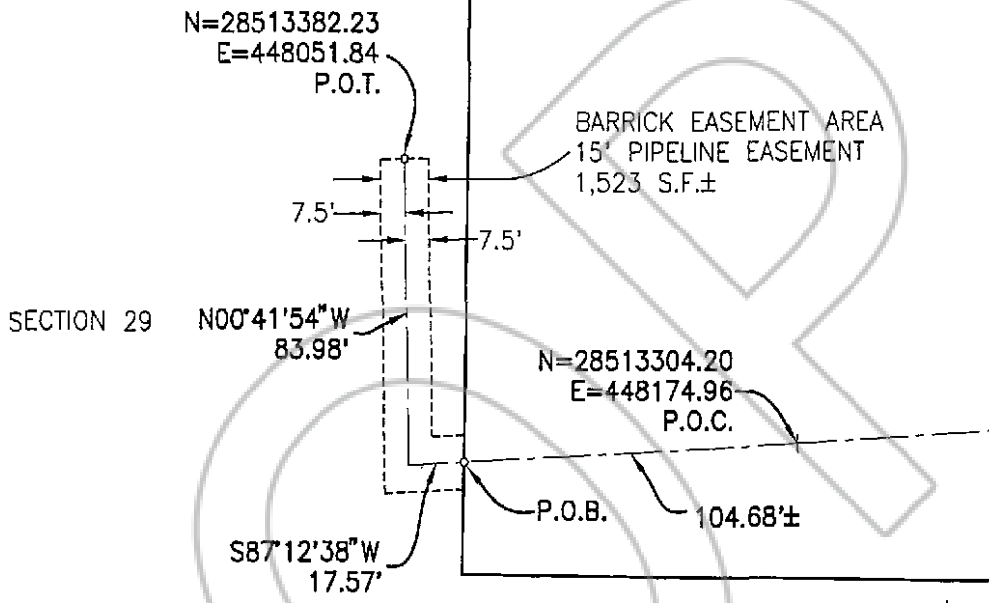
