### MEMORANDUM OF AMENDED AND RESTATED MINERAL LEASE

THIS MEMORANDUM OF MINERAL LEASE (this "Memorandum") memorializes that certain Amended and Restated Mineral Lease Agreement dated the 5 day of September, 2014 (the "Agreement"), by and among the "Damele Group" consisting of the following individuals: Leo G. Damele, in his own behalf and as the successor in a one-third interest of the share formerly held by Ellen M. Damele, deceased; Mary C. Damele in her own behalf; Mary J. Etchegaray in her own behalf and as the sole successor in interest to the share of Leroy E. Etchegaray, deceased; Robert L. Smith in his own behalf; Arlene D. Smith in her own behalf and as successor in a one-half interest of the share formerly held by Roberta M. Damele, deceased; Stephanie Sittner, as successor in a one-half interest of the share formerly held by Roberta M. Damele, deceased; Frederick L. Etchegaray in his own behalf; John J. Etchegaray in his own behalf; and Antone J. Damele in his own behalf and as successor in a one-third interest of the share formerly held by Ellen M. Damele, deceased; and Carol Heim, as successor in a one-third interest of the share formerly held by Ellen M. Damele, deceased), collectively with the address c/o Leo G. Damele, Diamond Valley HC62 Box 132, Eureka, Nevada 89316 (which living persons are collectively referred to herein as the "Lessors"); and the "Barrick Group" consisting of the following entities: Barrick Gold U.S. Inc., in its own behalf and as Manager for the Patty Project Joint Venture, an unincorporated joint venture association among Barrick Gold U.S. Inc., a California corporation, U.S. Gold Inc., a Colorado corporation; Chapleau Resources Ltd. A British Columbia corporation and Chapleau Resources (USA) Ltd., an Alaska corporation with the addresses c/o Barrick Gold U.S. Inc., 460 West 50 North, Suite 500, Salt Lake City, Utah 84101 (which entities are collectively referred to herein as the "Lessees").

#### **RECITALS**

The Damele Group, including their immediate predecessors in interest, entered into a Mineral Lease Agreement dated February 10, 1994 with White Knight Resources Ltd. (the "1994" Lease"). The Damele Group collectively holds all interests of the "Owners" as defined in the 1994 Lease. The 1994 Lease has been amended by seven prior amendments (as amended, the "Original Lease"). The Original Lease, as modified in the Agreement, leases to the Lessee all rights, titles and interests of the Lessors in and to the unpatented mining claims described on

Exhibit A-1 and depicted on Exhibit A-2, attached hereto and made a part hereof, all located in Eureka County, Nevada (collectively, the "**Property**"), together with interests thereafter acquired by the Parties in an area of interest comprised by the external boundaries of the Property.

#### **MEMORANDUM OF AGREEMENT**

- 1. This Memorandum is executed for the purpose of affording notice of the existence of the Agreement. This Memorandum is not intended to alter or vary the terms of the Agreement. If there are any inconsistencies between this Memorandum and the Agreement, the Agreement shall control. Capitalized terms not defined in this Memorandum are defined in the Agreement. The principal terms and provisions of the Agreement are summarized below.
- 2. Pursuant to the Agreement, the Original Lease is amended and restated in its entirety. Pursuant to the Agreement, the Lessors have reaffirmed the exclusive lease to the Lessees of 100% of their rights, titles and interests in and to the Subject Minerals in the Property, which Subject Minerals do not include the right to Excluded Minerals comprised of the commercial extraction of oil, gas, or associated hydrocarbons, or geothermal resources; provided however that the Lessees have no obligation to protect such Excluded Minerals. The Agreement also includes all options, contracts, licenses, easements and rights-of-way and all water rights of the Lessors related or pertaining to the Property. The rights granted under the Agreement include the rights of exploration, mining, constructing water wells, constructing mine facilities including crushers, waste piles and tailings piles, and other rights, including the right to use the Property in connection with similar uses on other properties held by the Lessees. The extent of such uses is in the sole determination of the Lessees.
- 3. The Primary Term of the Agreement is five (5) years from September 2, 2014. The Agreement will be automatically renewed at the expiration of the primary term for an additional ten (10) years, unless notice of termination is given by the Lessees at least thirty (30) days prior to the expiration of the Primary Term. The Agreement shall be deemed to be automatically renewed for successive Lease Years for so long as any exploration, development or mining operations have been conducted on the Property and any work commitment has been conducted, or any production royalties and/or advance minimum royalties have been paid with respect to the Property, in each case during the preceding twelve (12) months.
- 4. Unless the Agreement is sooner terminated, during the Primary Term, Lessees shall pay to the Lessors advance minimum royalty payments pursuant to the Agreement. If the Agreement is extended for an additional ten (10) year renewal term, Lessees shall pay a one-time advance royalty bonus payment to the Lessors. Thereafter, so long as the Agreement remains in effect, Lessees shall pay certain advance royalty payments to the Lessors at the beginning of each Lease Year commencing after the anniversary of the bonus payment.
- 5. Subject to a minimum amount and credit for the advance minimum royalty pursuant to a formula in the Agreement, the Lessees shall pay to the Lessors a production royalty of three percent (3%) Gross Value, based on the Recoverable Percentage, for all Subject Minerals mined from and removed for sale from the Property. Common Minerals, such as sand and gravel, used in the Lessees' operations are not subject to the production royalty. The Lessees have the right to commingle ore from the Property with other ore from other properties.

- 6. Lessees are responsible for all labor performed upon and materials furnished to the Property by the Lessees and in keeping the Property free from liens arising from the same. Lessees have the right to pay any liens and taxes relating to the Property that are not the responsibility of the Lessee and recover the costs from the Lessors. Lessees must comply with all federal, state and local laws with respect to their activities on the Property, and have the right to contest the same.
- 7. Until Commencement of Commercial Production, the Lessees must meet a certain work commitment for the Property. Lessees also have the right to amend and relocate unpatented mining claims on the Property. Lessees must maintain the unpatented mining claims during the term of the Agreement.
- 8. The Lessors are subject to certain confidentiality obligations relating to the Agreement.
- 9. None of the Parties may sell, lease nor assign any of its interest in the Agreement without the consent of the other Party, which consents will not be unreasonably withheld. Provided, however, without consent, any of the Lessors have the right to transfer to any other Lessor and to their heirs and descendants through estate planning and testamentary dispositions. Also, Lessees shall have the right to transfer their interests in whole or in part to any of their Affiliates and joint venture participants, and shall have the right to transfer their interests in whole or in part to Rye Patch Gold U.S. Inc. a Nevada corporation, pursuant to that certain Exploration, Development and Mine Operating Agreement made as of October 18, 2011, as the same may be amended from time to time. Nothing in the Agreement shall be deemed to be a limitation or restriction on transfer of any interest in surface or mineral estates held by the Lessees or any of them, which have been held or acquired by them not pursuant to leasehold interests under the Agreement or the Original Lease.
- 10. The Agreement grants Lessees a certain first right of refusal, in the event that during the term of the Agreement, the Lessors should desire to sell, assign or transfer their interest in the Property or in the Agreement.
- 11. In the event the Lessors believe Lessees to be in default in the observance or performance of any of Lessee's covenants, agreements or obligations under the Agreement, the Lessors may give written notice of such alleged default, specifying the details of the same. Lessees shall have thirty (30) days following said notice within which to remedy the default described therein, or with respect to a default which cannot be cured by payment of money, to commence action in good faith to remedy such default. Unless Lessees shall so comply or commence to comply, the Agreement may be terminated at the option of the Lessors; provided, however, that in the event Lessees believe that it is not in default, Lessees may give written notice to the Lessors within such thirty (30) day period setting forth such fact, and in such event the Lessors must secure a final judicial determination by a court of competent jurisdiction that such default in fact exists.
- 12. It is not the purpose or intention of the Agreement to create a partnership, mining partnership, commercial partnership, joint venture or any other partnership relation between the Parties hereto.
- 13. The Lease shall be governed by and interpreted in accordance with the laws of the State of Nevada.
