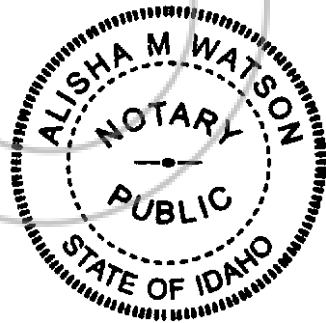
Correction Notice of Intent to Hold
