**ASSIGNMENT OF OVERRIDING ROYALTY INTEREST**



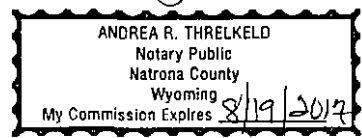
