Thence South 77°41'30" East, a distance of 112.53 feet to a point on the West end line of Lot 14;

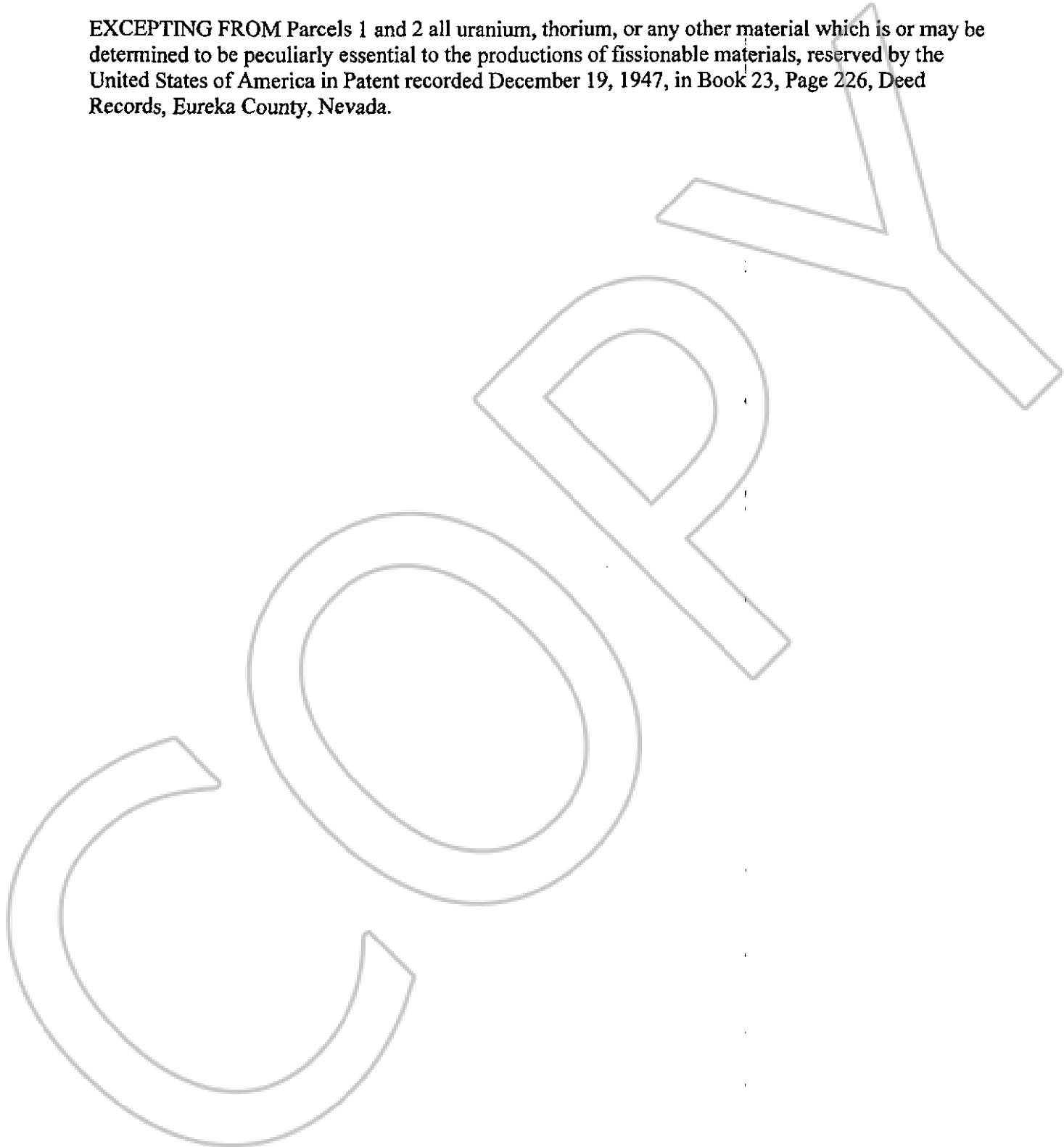
