The Discovery Monument is located NORTH 53° 0 Minutes 24 Seconds EAST, A Distance of 3,237 feet  
From the following natural/permanent monument: SW corner of section 35 T22N R54E

The claim is approximately 1500 feet long and 600 feet wide, such that 750 feet are claimed in a  
NORTHEAST direction and 750 feet in a SOUTHWEST direction from the point of discovery (monument  
of location), at which the Notice of Location was posted, together with 300 feet on each side of the  
monument of location and center line of the Claim. The general course of the lode or vein is from the  
SOUTHWEST to the NORTHEAST direction.
