Whereas, there has been no public notice of sale of such property by the County Treasurer prior to the request of reconveyance.

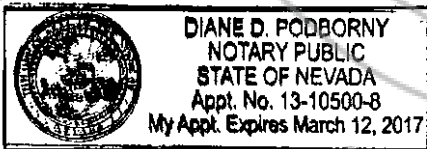
