MEMORANDUM OF WATER RIGHT LEASE

THIS MEMORANDUM OF WATER RIGHT LEASE dated as of December 1st, 2014, ("Effective date") between JAMES P. and MONIQUE ITHURRALDE, HUSBAND and WIFE, and HOMESTAKE MINING COMPANY OF CALIFORNIA, a California corporation whose mailing address is 293 Spruce Road, Elko, NV 89801 ("Lessee") shall provide notice that the parties shown above have entered into a Water Right Lease as of the Effective Date. The pertinent terms of the Water Right Lease are:

- Lease and Term. (a) Lessors are the owners of Permit No.18909 (Certificate No. 6560), Permit No. 24827 (Certificate No. 7944), Permit No. 64207 and Permit No. 64439 (the "Water Rights") for irrigation of land located in the same groundwater basin as the Ruby Hill Mine.
- Lessors are willing to lease the Water Rights to Lessee, and Lessee is willing to lease the Water Rights from Lessors pursuant to the terms and conditions of the Water Rights Lease as summarized herein.
- Subject to the terms and provisions of the Water Right Lease Lessors have leased to Lessee, Lessors' right title and interest in Five Hundred Eighty-One and 452/1000 (581,452) acre feet of the Water Rights (the "Leased Water") and have reserved three (3) acre feet for Lessors' use from Permit No. 24827 (Certificate No. 7944).
- This Agreement shall commence on the Effective Date and continue for an (d) initial term of ten years.
- (e) Lessee may give notice to extend the Water Right lease for an additional ten year term subject to the terms and conditions provided in the Water Right Lease.
- Modification of Agreement. The Water Right Lease may be amended or varied only by a writing signed by both parties.

3, <u>Additional Terms</u>. Additional terms and conditions are contained in the Water Right Lease between the parties. This Memorandum of Water lease shall not modify said agreement.
