Hamm, attorney for Plaintiff M-I, L.L.C. d/b/a MI-SWACO, do hereby certify that, in a certain suit filed in the 270th Judicial District Court of Harris County, Texas, wherein M-I, L.L.C. d/b/a MI-SWACO is the Plaintiff and Alternative Drilling Company, LLC is the Defendant in Cause No. 2014-63494. 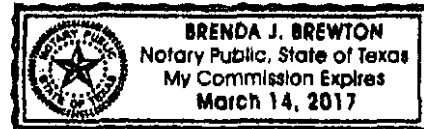

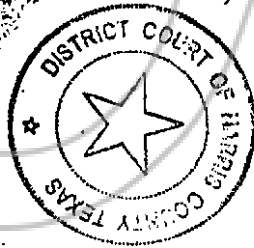

FINAL JUDGMENT

After considering Plaintiff M-I, L.L.C. d/b/a MI-SWACO's Motion for Default Judgment against Alternative Drilling Company, LLC ("Defendant"), the pleadings and the affidavits, the Court

GRANTS Plaintiff's Motion for Default Judgment against Defendant. The Court **ORDERS, ADJUDGES and DECREES** that Plaintiff M-I, L.L.C. d/b/a MI-SWACO have judgment against Defendant:

- (a) Money damages, as a consequence of Defendant's refusal to pay on the sworn account and for breach of contract in the amount of \$57,251.96, exclusive of interest;
- (b) Pre-judgment interest from Defendant at the rate of 18% per annum beginning September 7, 2014 until the date of judgment;
- (c) Costs of Court expended in this action against Defendant in the amount of \$275.50,
- (d) Reasonable attorneys' fees and expenses incurred for legal services in the amount of \$1,965.00 (attorneys' fees) and \$176.12 (expenses) for all work done to adjudicate the breach of contract claims; and
- (e) Post-judgment interest against Defendant from the date of judgment until date paid at the rate of 18% per annum.

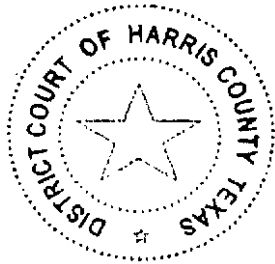
