ASSIGNMENT OF MINING LEASE

RECITALS

A. H. Deworth Williams, also known as H.D. Williams, and Blue Cap Development Corp., a Nevada corporation (collectively "Owner") and Platte River Gold (U.S.) Inc. 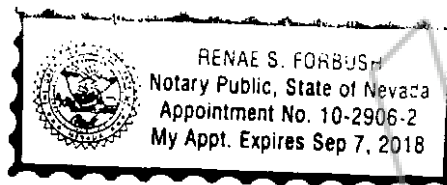
