

1. Pursuant to the provisions of 30 U.S.C. §§ 28f-k and 43 C.F.R. §§ 3834.10 to -23, a claim maintenance fee of \$155.00 is to be paid to the Bureau of Land Management for each non-exempt mining claim, mill site, or tunnel site for the assessment year ending September 1, 2016, in lieu of the requirement to perform and record affidavits of proof of annual assessment work for mining claims and to record a notice of intent to hold mill sites under 30 U.S.C. §§ 28-28e and 43 U.S.C. § 1744.
2. On July 28, 2015, Homestake Mining Company of California timely paid the federal claim maintenance fee of \$155.00 for each of the 789 claims and/or mill sites situated in County of Eureka, State of Nevada identified in the attached Exhibit A ("Claims and Mill Sites"), in accordance with federal law.
3. The name and current mailing address of the owner of the Claims and Mill Sites is: Homestake Mining Company of California, 460 West 50 North, Suite 500, Salt Lake City, Utah, 84101.
4. The serial number assigned to each Claim and Mill Site by the Bureau of Land Management is shown on Exhibit A.

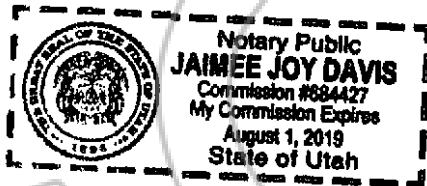
