**AFFIDAVIT AND  
NOTICE OF INTENTION TO HOLD  
UNPATENTED MINING CLAIMS - GC CLAIM GROUP  
FOR THE NEVADA STATE ASSESSMENT YEAR ENDING SEPTEMBER 1, 2015**

The undersigned, being first duly sworn, states under penalty of perjury that the statements herein are true:

2. REDSTAR GOLD USA INC., whose address is 5301 Longley Lane, Suite H122, Reno, Nevada, 89511 ("Owner") holds and claims the GC mining claim group, which is located in Sections 1 and 2 of Township 16 North Range 52 East and Sections 6 and 7 of Township 16 North Range 53 East, MDB&M, Eureka County, Nevada. The full names of the mining claims, the County Document numbers and the Bureau of Land Management mining claim serial numbers assigned to the mining claims are described in the Exhibit "A", attached hereto and by this reference incorporated in this Affidavit.

3. **Federal Law.** Owner has paid to the Nevada State Office of the Bureau of Land Management, on or before September 1, 2015, a maintenance fee in the amount of \$155.00 for each Claim, pursuant to 30 U.S.C.A. § 28f(a) and 28j(c) and related regulations (the "Act"). Such payment was made to hold the Claims for the federal assessment year ending at noon on September 1, 2016, as required by the Act. The maintenance fees are in lieu of the performance of annual assessment work and the recording of an affidavit of labor under Section 314 of the Federal Land Policy and Management Act of 1976 and 43 CFR 3833.2; and,
