**ROYALTY DEED****(Redhill Hill Project, Eureka County, Nevada)**

This Royalty Deed (this "Deed") is made and entered into effective this 2<sup>nd</sup> day of March, 2016 from NULEGACY GOLD CORPORATION NV, a Nevada corporation ("NuLegacy"); to BARRICK GOLD EXPLORATION INC., a Delaware corporation ("Barrick"), whose address is 293 Spruce Road, Elko, Nevada 89801-4491 (each a "Party" and together, the "Parties").

**Recitals**

A. NuLegacy desires to grant to Barrick a "Net Profits Royalty" (defined herein) in the "Property" more particularly described in Exhibit A attached hereto (hereinafter the "Property").

B. All capitalized words not otherwise defined herein shall have the respective meanings set forth in Exhibit B.

THEREFORE, for and in consideration of the sum of ten dollars (\$10.00) now paid by Barrick to NuLegacy and other good and valuable consideration, the receipt and sufficiency of which is acknowledged, and intending to be legally bound, the Parties agree as follows:

**Net Profits Royalty****1. Net Profits Royalty.**

1.1. **Grant of Royalty.** NuLegacy hereby grants to Barrick, its successors and assigns forever, and NuLegacy covenants for itself and its successors and assigns, to pay to Barrick, a production royalty of 2.0% of the Net Profits from production of ores, minerals and other products extracted from the Property (the "Net Profits Royalty"); provided, however, such Net Profits Royalty shall be payable only from and after the commencement of "Commercial Production" (herein defined) from the Property or from any part thereof, and further subject to the terms and conditions set out herein. For greater certainty, the Net Profits Royalty shall encumber only the Property and be payable solely from Net Profits

- 4.12. **Arbitration.** Either Party may refer any Arbitration Dispute to arbitration by written notice to the other Party. Within thirty (30) days after receipt of such notice, the Parties will endeavor to agree upon the appointment of a single arbitrator, who will be capable of commencing the arbitration within twenty-one (21) days of his or her appointment. The arbitrator will be a person who by a combination of education and experience is experienced in mining disputes and otherwise is competent to adjudicate the matter in dispute and who has indicated his or her willingness and ability to act as arbitrator accordance with this Section 4.12. The arbitration will be governed by the rules and procedures of the AAA, except as they may be modified by the mutual agreement of the Parties. The place of arbitration will be Reno, Nevada and the award of the arbitrator will be final and binding upon the Parties and will not be subject to appeal or judicial review absent fraud or manifest error.
- 4.13. **Severability.** If any part, term or provision of this Deed is held by a court of competent jurisdiction to be illegal or in conflict with any laws or regulations, the validity of the remaining portions or provisions shall not be affected, and the rights and obligations of the Parties shall be construed and enforced as if this Deed did not contain the particular part, term or provision held to be invalid.
- 4.14. **Entire Agreement.** This Deed constitutes the entire agreement between the Parties with respect to the subject matter hereof.



**EXHIBIT B**  
**CERTAIN DEFINED TERMS**

1. **"Affiliate"** means, in respect of a Party, each entity that is controlled by, or under common control with, such Party, where control is effected by owning a majority of the equity interests in, or by a voting trust or other agreement pertaining to, such Party.
2. **"Capital Expenditure"** means all expenditures, payments and costs determined without duplication, charged to and/or incurred by NuLegacy that are treated as capital items under IFRS, and that are incurred by NuLegacy directly relating to the Exploration, Development and Mining of the Property, and made by NuLegacy after the date of this Royalty Deed including those capital expenditures arising from the following:
  - (a) Evaluating, determining the feasibility of, and constructing and equipping of mines, leach pads, shafts, adits, haulage ways, roads, tracks, access ways, waste dumps, tailings areas, and all costs of any related property, plant and equipment for the Property (collectively, "**Mines**");
  - (b) Evaluating, determining the feasibility of, and constructing and equipping of all mills, crushers, grinders, buildings, concentration and beneficiation facilities, smelters, refineries and other treatment or processing facilities, any storage and warehouse facilities for ore or other Products derived from such Mines, all administrative and office facilities for the same and other fixtures, utilities (power, water, sewer and other utilities), all transportation facilities for moving ore or other Products derived from Mines or such facilities and/or any Products derived therefrom and all costs of any related property, plant and equipment (collectively, "**Facilities**");
  - (c) Compliance with applicable laws protecting the environment including preparation of environmental impact statements, and the obtaining of permits necessary for development and operation of the Property;
  - (d) The acquisition and provision of utilities, housing for employees, training of employees, medical and recreational facilities, and similar infrastructure costs and expenses (collectively, "**Infrastructure Facilities**");
  - (e) Acquisition (whether in fee, by lease or otherwise) of lands, minerals, surface rights, or other real property and the costs of holding and maintenance of the same, including payments to third parties, and any costs of curing title, perfection of interests, and removal of liens and encumbrances of (i) the Property; and (ii) any other real property interests acquired in connection therewith or related to operations thereon, whether within or outside of the exterior boundaries of the Property (collectively, "**Real Property**") and whether or not such other properties are subject to the royalty payments described herein and including the acquisition of any mill site claims outside of the exterior boundary of the Property and



- associated tailings facilities to permit processing and recovery of ores from the Property;
- (f) Working capital and raw materials, spare parts and other inventory to the extent capitalized;
  - (g) Expanding, improving, modifying, equipping, rehabilitating and replacing Mines, Facilities, Infrastructure Facilities and Real Property; and
  - (h) All other costs, whether similar or dissimilar to the foregoing that are properly treated as capital items under IFRS, including any items described under Operating Expenses that NuLegacy elects to capitalize. Capital Expenditures shall not include any Operating Expenses.
3. **"Code"** means the Internal Revenue Code of 1986, as amended, together with all regulations and rulings adopted from time to time thereunder.
4. **"Commercial Production"** means, and is deemed to have been achieved, in each case in respect of any of the Property, when the earliest of the following has occurred: (a) when any concentrator, heap leach facility, or other processing facility constructed for processing ores from the Property, for other than testing purposes, has operated for a period of thirty (30) production days in any period of ninety (90) days for the commercial processing of ore from the Property; (b) if at least two thousand (2000) tons of ore from the Property is sold by NuLegacy without processing; (c) when at least two thousand (2000) gallons of leachate from any heap leach pile on which ore from the Property is placed, is processed to recover precious metals or base metals; or (d) when sales of any products extracted from the Property of at least US\$50,000 has occurred, regardless of the type of products. Provided, however, the term "Commercial Production" specifically excludes the milling of ores for the purpose of testing or milling (to a maximum of 500 tons in respect of the Property) by a pilot plant or milling during an initial tune-up period of a plant; provided, however, that the recovery of any products during such testing shall be applied against any Expenditures.
5. **"Development"** means all activities and preparation directed toward the removal and recovery of products from the Property, including the construction or installation of a mill or any other improvements to be used for the mining, handling, milling, processing or other beneficiation of products, including any additional in-fill drilling or exploration within the Property. For purposes of clarity, exploration outside of the boundary of the Property shall not be allocated as a Capital Expenditure or Operating Expense of the Property under this Deed.
6. **"Expenditures"** means, subject to Section 1.3 of the Deed, the sum of the following:
- (a) The amount of depreciation and amortization taken by NuLegacy under the Code with respect to Capital Expenditures related to the Property as determined under IFRS standards for the relevant period, determined without duplication;

- (b) All Operating Expenses taken by NuLegacy under the Code related to the Property as determined under IFRS standards for the relevant period, determined without duplication.
7. **“Exploration”** means all activities directed toward ascertaining and evaluating the existence, location, quantity, quality or commercial value of deposits of minerals and the geological, environmental, technical and economic requirements and attributes that may be appropriate in making a decision to commercially mine and process the same. Exploration includes all activities undertaken through the completion of a feasibility study, if any, but shall not include construction of commercial Mining, milling or processing facilities or commencement of Commercial Productions or any exploration conducted by NuLegacy outside of the boundaries of the Property.
8. **“Governmental Entity”** means (i) any applicable US, state, tribal or local governmental or public department, central bank, court, commission, board, bureau, agency, commissioner or instrumentality, whether federal, state, county, municipal, local; (ii) any subdivision or authority of any of the above; (iii) any stock exchange; and (iv) any quasi-governmental or private body exercising any regulatory, expropriation or taxing authority under or for the account of any of the above.
9. **“Gross Revenue”** means, subject to Section 1.3 of the Deed, the gross revenues received by NuLegacy and its Affiliates on a combined basis, arising from the total gross amount of all sales of ores, minerals, or other products extracted or produced from the Property and all other receipts or receivables whatsoever from all business conducted on or from the Property, and any insurance proceeds to the extent not applied to reconstruct any asset for the Property including arising from any casualty loss relating to the Property, and whether those sales or other receipts be evidenced by check, cash, electronic payment, credit, charge accounts, exchange or otherwise. If any part of the operations on the Property shall be subcontracted or conducted by any person, firm or corporation other than NuLegacy or its Affiliates, then the total amount of all sales and other receipts of that subcontractor or other person, firm or corporation shall, without duplication, be included in Gross Revenue for the purpose of calculating the Net Profits Royalty payable hereunder. For purposes of clarity, if any products from the Property are transferred to any Affiliate of NuLegacy prior to the final sale to a non-Affiliate, the total gross revenue from NuLegacy and each such Affiliate shall be included as gross revenue. Notwithstanding the foregoing and for greater certainty, Gross Revenue shall not include any revenues received by NuLegacy or its Affiliates from any ores, minerals, or other products produced from other properties that have been commingled with ores, mineral and other products produced from the Property in accordance with Section 2.1 of the Deed.
10. **“IFRS”** means the International Financial Reporting Standards as promulgated from time to time by the International Accounting Standards Board and the IFRS Interpretations Committee, consistently applied by NuLegacy.



11. **"Mining"** means the mining, extracting, producing, handling, milling, beneficiation or other processing of products produced from the Property and the sale and marketing or other distribution thereof.
12. **"Net Profits"** means, with respect to any period, the Gross Revenue for such period less all Expenditures for such period, determined in accordance with IFRS.
13. **"Operating Expenses"** shall mean all expenditures, payments and costs that are recognized as expensed items under IFRS by NuLegacy relating to the Exploration, Development and Mining of the Property, including without limitation, all such expenditures, payments and costs of, or related to, the following, whether located on or off the Property and taken after the date of this Royalty Deed and determined without duplication, but excluding any Capital Expenditures or any charge for depreciation or amortization:
  - (a) Pre-development and stripping including without limitation, gaining access to ore or evaluation thereof, drilling, preparing stockpiling areas and other pre-production activities;
  - (b) Exploration, Development, Mining including milling, processing, smelting and refining, compliance with laws protecting the environment, and whether using NuLegacy's own forces or contract labor, including contract mining, custom or toll milling and custom or toll smelting and refining costs and transportation costs of such Products to the mill and/or the smelter and/or to the purchaser thereof;
  - (c) Maintaining, repairing and replacing property, plant and equipment;
  - (d) All selling and delivery costs;
  - (e) Expanding, improving, modifying, equipping, rehabilitating and replacing Mines, Facilities, Infrastructure Facilities, and Real Property;
  - (f) All rates, assessments, duties, royalties and other fees and all Taxes (in each case other than the Net Profits Royalty under this Royalty Deed), payable to third parties or to any Governmental Entity charged, levied or imposed on Mines, Facilities, Infrastructure Facilities, Real Property and the Property, or payable on or in respect of or measured by the Products produced from such mine, including all governmental and third party royalties relating thereto and mining duties or mining taxes; excluding only federal, state and local income and franchise taxes assessed on NuLegacy or of its Affiliates;
  - (g) Interest and other debt service costs for debt financing arrangements or other borrowed funds for the acquisition, Development or Mining of all Mines, Facilities, Infrastructure Facilities, and Real Property;
  - (h) All expenses incurred directly for activities on or in connection with the Property by NuLegacy's head office including the pro-rata portion of salaries, fees, wages, and expenses of NuLegacy's head office personnel including management,



- technical, legal, accounting, clerical and secretarial personnel, actually and directly performing work on or in connection with the Property;
- (i) Other costs that are properly treated as expense items under IFRS, including without limitation, but without duplication, any items described as Capital Expenditures, that NuLegacy elects to treat as expense items; and
  - (j) An amount equal to five percent (5%) of the Operating Expenses for NuLegacy's head office overhead and general and administrative expenses, that are not charged as Operating Expenses under Section 13(h) above.
14. **"Taxes"** means any and all present or future taxes (including value added taxes), duties, levies, excises, fees, imposts, premiums, deductions, charges, assessments or withholdings of any kind whatsoever imposed by any Governmental Entity, whether computed on a separate, consolidated, unitary, combined or other basis and any and all liabilities (including interest, fines, penalties or additions to tax or other additional amounts imposed by any Governmental Entity) with respect to the foregoing; but not including any tax based on income or franchise taxes of NuLegacy or its Affiliates.
