**AFFIDAVIT AND
NOTICE OF INTENTION TO HOLD
UNPATENTED MINING CLAIMS - L CLAIM GROUP
FOR THE NEVADA STATE ASSESSMENT YEAR ENDING SEPTEMBER 1, 2016**

The undersigned, being first duly sworn, states under penalty of perjury that the statements herein are true:

1. REDSTAR GOLD USA INC., whose address is 800 West Pender Street, Suite 615, Vancouver, B.C., V6C 2V6, Canada ("Owner") holds and claims the L mining claim group, which is located in Section 3 of Township 22 North Range 51 East and Sections 34 and 35 of Township 23 North Range 51 East, MDB&M, Eureka County, Nevada. The full names of the mining claims, the County Document numbers and the Bureau of Land Management mining claim serial numbers assigned to the mining claims are described in the Exhibit "A", attached hereto and by this reference incorporated in this Affidavit.

Owner further expresses its intent to hold and maintain all of its right, title and interest in and to each of the Claims through the end of the Nevada State assessment year beginning 12:00 P.M. on September 1, 2016 and ending 11:59A.M. on September 1, 2017.
3. **Federal Law.** Owner has paid to the Nevada State Office of the Bureau of Land Management, on or before September 1, 2016, a maintenance fee in the amount of \$155.00 for each Claim, pursuant to 30 U.S.C.A. § 28f(a) and 28j(c) and related regulations (the "Act"). Such payment was made to hold the Claims for the federal assessment year ending at noon on September 1, 2017, as required by the Act. The maintenance fees are in lieu of the performance of annual assessment work and the recording of an affidavit of labor under Section 314 of the Federal Land Policy and Management Act of 1976 and 43 CFR 3833.2; and,
4. By such payments, by Owner's compliance with applicable federal and state mining laws and regulations, and by this Affidavit, Owner hereby expresses its intent to hold and maintain all of its right, title and interest in and to each of the Claims through the end of the federal assessment year ending at noon on September 1, 2017;

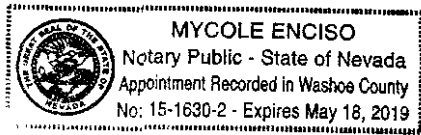
