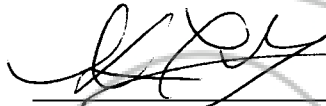

1. 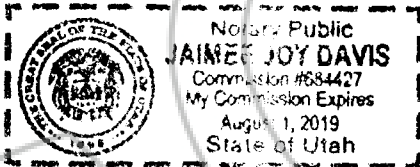

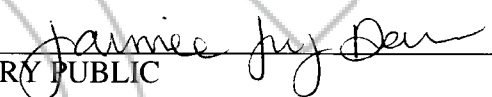
