Being duly authorized, I make this affidavit on behalf of Homestake Mining Company of California, 460 West 50 North, Suite 500, Salt Lake City, Utah, 84101; and Barrick Gold U.S. Inc., 460 West 50 North, Suite 500, Salt Lake City, Utah, 84101.

1. 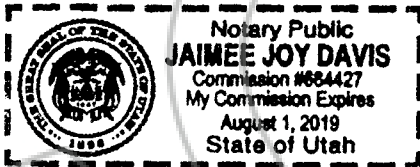


