
It is the intention of Pescio Exploration, LLC to maintain, develop, and hold the claims as is provided by law.

All such maintenance fees are paid on behalf of Pescio Exploration, LLC.

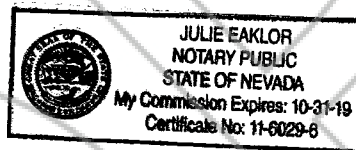
