CERTIFICATE OF LOCATION

NOTICE IS HEREBY GIVEN that **US Gold Acquisition Corp.**

The name of the claim is the PC 22.

This claim was located on 9/9/2017, by posting a Location Notice at the discovery monument.

The length of the claim is 20 feet in a South direction and 1480 feet in the opposite direction
from the monument where the Location Notice is posted, and the width is 300 feet on each side of the center of
the vein or lode, comprising in all 1500 feet in length and 600 feet in width, and generally following a
North to South course.

The exterior boundaries are distinctly marked by four substantial monuments. Each corner monument
consists of a 1-1/2" x 1-1/2" x 4' wooden post with aluminum tags attached, scribed with claim name and corner
