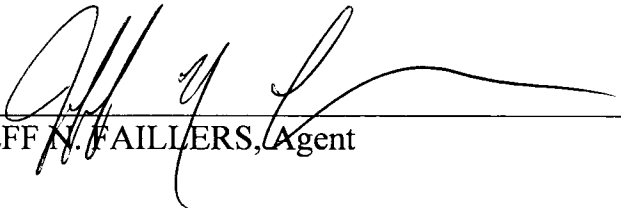
Notice of Intent to Hold and Affidavit of Payment of Fees

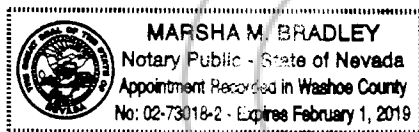
