State of Nevada, and bounded and particularly described as follows, to-wit:

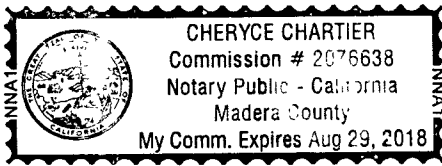
