Has located the PCY 288 Lode Mining Claim on September 26, 2017 whose dimension are approximately 1500 feet by 600 feet. By this Declaration and such location, the above named locator(s) claim all veins, lodes, ledges, deposits and surface ground within the boundaries of said claim.

Said Claim is a lode it being situated in the above mentioned county and state, and it is distinctly marked on the ground so that its boundaries may be readily traced by four 1.5" x 1.5" wooden posts four feet long. Each monument is marked with a scribed metal tag, which states the claim name and number, and the location of the monument with respect to the claim.

Beginning at the NE corner (Cor. No 1), thence 1500 feet South 45° East to the SE Corner (Cor. No. 2), thence 600 feet South 45° West to the SW Corner (Cor. No. 3), thence 1500 feet North 45° West to the NW Corner (Cor. No. 4), thence 600 feet North 45° East to the Point of Beginning.

227 The Claim is approximately 1500 feet long and 600 feet wide, such that ¹²⁷³~~1076~~ feet are claimed in a southeasterly and ~~424~~ feet in a northwesterly from the point of discovery (monument of location), at which the Notice of Location was posted, together with 300 feet on each side of the monument of location and center line of the Claim. The general course of the lode or vein is from the northwesterly to the southeasterly direction.

The NE corner of the claim is 11241 feet West 17° North from the SE Corner of Section 36 T16N R52E


