CERTIFICATE OF LOCATION
LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that the HUN 12 lode mining claim has been located by Golden Pick LLC, whose current mailing address is 2215 N. 5th St., Elko NV 89801, on the 1st day of June, 2018.

The claim is approximately 1500 feet in length and 600 feet in width, such that 50 feet are claimed in a Westerly direction and 1450 feet in an Easterly direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with 300 feet on each side of the monument of location and center line of the claim. The general course of the lode or vein, as near as it may be determined, is Westerly to Easterly, and it is situated in Eureka County, Nevada.

The exterior boundaries of the claim are distinctly marked by four wooden posts that are at least 1 ½ inches by 1 ½ inches by 4 feet tall, set one foot in the ground, with scribed metal tags, one at each corner of the claim, and the location monument along the centerline of the claim. The claim is more particularly described by metes and bounds as follows:

Beginning at the point of discovery (the monument of location), which is approximately 50 feet west, and 1128 feet north to a natural object or permanent monument, being the Northeast corner of Section 24, Township 22 North, Range 50 East, thence 50 feet Westerly to the true point of beginning, thence 300 feet north to Corner 1, the NW corner of the claim, marked HUN 12, thence 1500 feet east to Corner 2, the NE corner of the claim, marked HUN 12, thence 600 feet south to Corner 3, the SE corner of the claim, marked HUN 12, thence 1500 feet west to Corner 4, the SW corner of the claim, marked HUN 12, thence 300 feet north to the true point of beginning.

The claim encompasses portions of the following quarter section(s), section(s), township(s), and range(s):

NW¼ Section 19, Township 22 North, Range 51 East
Mount Diablo Meridian, Eureka County, State of Nevada.

The boundaries of the claim were defined as required by law within 60 days from the date of posting of the Notice of Location. The work of location consisted of making a claim map as provided in N.R.S. 517.040.
