CERTIFICATE OF LOCATION
LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that the **HUN 31** lode mining claim has been located by Golden Pick LLC, whose current mailing address is **2215 N. 5th St., Elko NV 89801**, on the **1st day of June, 2018**.

The claim is approximately **1500** feet in length and **600** feet in width, such that **300** feet are claimed in a **Westerly** direction and **1200** feet in an **Easterly** direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with **300** feet on each side of the monument of location and center line of the claim. The general course of the lode or vein, as near as it may be determined, is **Westerly to Easterly**, and it is situated in Eureka County, Nevada.

The exterior boundaries of the claim are distinctly marked by four wooden posts that are at least 1 ½ inches by 1 ½ inches by 4 feet tall, set one foot in the ground, with scribed metal tags, one at each corner of the claim, and the location monument along the centerline of the claim. The claim is more particularly described by metes and bounds as follows:

Beginning at the point of discovery (the monument of location), which is approximately **2898.3** feet west, and **5094** feet north to a natural object or permanent monument, being the **Northeast corner of Section 24, Township 22 North, Range 50 East**, thence **300 feet Westerly** to the true point of beginning, thence **300 feet north** to Corner 1, the NW corner of the claim, marked **HUN 31**, thence **1500 feet east** to Corner 2, the NE corner of the claim, marked **HUN 31**, thence **600 feet south** to Corner 3, the SE corner of the claim, marked **HUN 31**, thence **1500 feet west** to Corner 4, the SW corner of the claim, marked **HUN 31**, thence **300 feet north** to the true point of beginning.

The claim encompasses portions of the following quarter section(s), section(s), township(s), and range(s):

SE¼ Section 19, Township 22 North, Range 51 East
NE¼ Section 30, Township 22 North, Range 51 East
Mount Diablo Meridian, Eureka County, State of Nevada.

The boundaries of the claim were defined as required by law within 60 days from the date of posting of the Notice of Location. The work of location consisted of making a claim map as provided in N.R.S. 517.040.
