**CERTIFICATE OF LOCATION**  
**LODE MINING CLAIM**

NOTICE IS HEREBY GIVEN that the **WGB 42** lode mining claim has been located by **WKGUS LLC**, whose current mailing address is **2215 N. 5<sup>th</sup> St., Elko NV 89801**, on the **24th** day of **May, 2018**.

The claim is approximately **1500** feet in length and **600** feet in width, such that **50** feet are claimed in a **westerly** direction and **1450** feet in an **easterly** direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with **300** feet on each side of the monument of location and center line of the claim. The general course of the lode or vein, as near as it may be determined, is **westerly to easterly**, and it is situated in Eureka County, Nevada.

The exterior boundaries of the claim are distinctly marked by four 2" x 2" wooden posts extending at least three feet above the surface of the ground, with scribed metal tags, one at each corner of the claim, and the location monument along the centerline of the claim. The claim is more particularly described by metes and bounds as follows:

Beginning at the point of discovery (the monument of location), which is approximately **4945.8** feet **north**, and **2632.6** feet **west** to a natural object or permanent monument, being the **Southwest Corner Section 30, Township 23 North, Range 50 East**, thence **50 feet west** to the true point of beginning, thence **300 feet north** to Corner 1, the **NW** corner of the claim, marked **WGB 42**, thence **1500 feet east** to Corner 2, the **NE** corner of the claim, marked **WGB 42**, thence **600 feet south** to Corner 3, the **SE** corner of the claim, marked **WGB 42**, thence **1500 feet west** to Corner 4, the **SW** corner of the claim, marked **WGB 42**, thence **300 feet north** to the true point of beginning.

The claim encompasses portions of the following quarter section(s), section(s), township(s), and range(s):

NE $\frac{1}{4}$ , NW $\frac{1}{4}$  Section 6, Township 22 North, Range 50 East  
SW $\frac{1}{4}$ , SE $\frac{1}{4}$  Section 31, Township 23 North, Range 50 East  
Mount Diablo Meridian, Eureka County, State of Nevada.

The boundaries of the claim were defined as required by law within 60 days from the date of posting of the Notice of Location. The work of location consisted of making a claim map as provided in N.R.S. 517.040.
