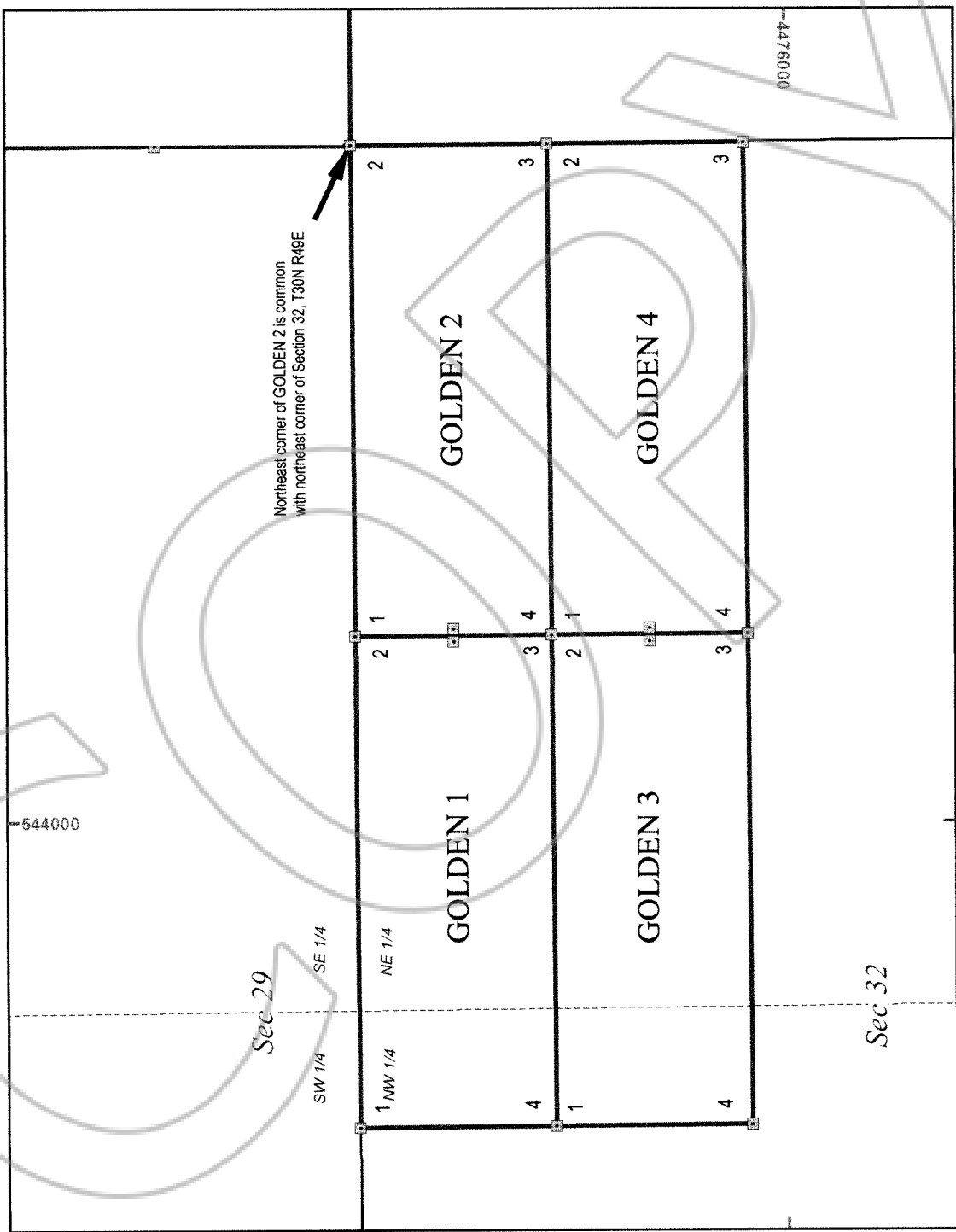

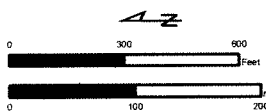

Regarding the above referenced lode mining claims, SWS 1-4, Sec. 26, T.19N., R.52E. (Doc. Nos. 235853-235856), we have noticed that the recorded map “AMENDED Map of the SWS 1-4 Mining Claim Group” references and shows all four SWS claims. Only three Amended Certificates of Locations were filed with the Eureka County Recorder, for claims SWS 1, 2, and 4. Please check your certificates accordingly and make any revisions necessary to the map, so that we may resolve any discrepancies.
