CERTIFICATE OF LOCATION
LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that the **AE 16** lode mining claim has been located by **McEwen Mining Nevada Inc.**, whose current mailing address is **2215 N. 5th St., Elko, NV 89801**, on **August 13, 2018**.

The claim is approximately **1500** feet in length and **600** feet in width, such that **10** feet are claimed in a **northerly** direction and **1490** feet in a **southerly** direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with **300** feet on each side of the monument of location and center line of the claim. The general course of the lode or vein, as near as it may be determined, is **northerly** to **southerly**, and it is situated in Eureka County, Nevada.

The exterior boundaries of the claim are distinctly marked by four 2" x 2" wooden posts extending at least three feet above the surface of the ground, with scribed metal tags, one at each corner of the claim, and the monument of location along the centerline of the claim. The claim is more particularly described by metes and bounds as follows:

Beginning at the point of discovery (the monument of location), which is approximately **2250** feet **north**, and **740** feet **east** to a natural object or permanent monument, being the **NW** corner of **Section 28, T22N, R51E, M.D.M.** thence **10** feet **north** to the true point of beginning, thence **300** feet **east** to Corner 1, the **NE** corner of the claim, marked **AE 16**, thence **1500** feet **south** to Corner 2, the **SE** corner of the claim, marked **AE 16**, thence **600** feet **west** to Corner 3, the **SW** corner of the claim, marked **AE 16**, thence **1500** feet **north** to Corner 4, the **NW** corner of the claim, marked **AE 16**, thence **300** feet **east** to the true point of beginning.

The claim encompasses portions of the following quarter section(s), section(s), township(s), and range(s):

NE 1/4 of Section 29, T22N, R51E, M.D.M.

SE 1/4 of Section 29, T22N, R51E, M.D.M.

in Eureka County, State of Nevada.

The boundaries of the claim were defined as required by law within 60 days from the date of posting of the Notice of Location. The work of location consisted of making a claim map as provided in N.R.S. 517.040.
