## **CERTIFICATE OF LOCATION** LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that the AE 26 lode mining claim has been located by McEwen Mining Nevada Inc., whose current mailing address is 2215 N. 5th St., Elko, NV 89801, on August 13, 2018.
