

1. Pursuant to the provisions of 30 U.S.C. §§ 28f-k and 43 C.F.R. §§ 3834.10 to -23, a claim maintenance fee of \$155.00 is to be paid to the Bureau of Land Management for each non-exempt mining claim, mill site, or tunnel site for the assessment year ending September 1, 2019, in lieu of the requirement to perform and record affidavits of proof of annual assessment work for mining claims and to record a notice of intent to hold mill sites under 30 U.S.C. §§ 28-28e and 43 U.S.C. § 1744.
2. On August 30, 2018, Barrick Gold U.S. Inc., timely paid the federal claim maintenance fee of \$155.00 for each of the 35 claims and/or mill sites situated in County of Eureka, State of Nevada identified in the attached Exhibit A ("Claims and Mill Sites"), in accordance with federal law.

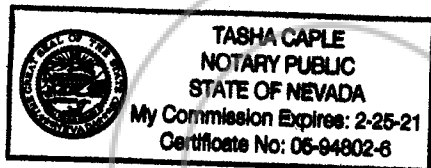
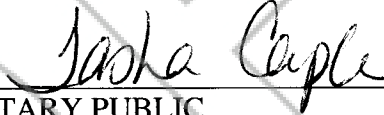
