CERTIFICATE OF LOCATION
LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that the **SGB 47** lode mining claim was located by **McEwen Mining Nevada Inc.**, whose current mailing address is **2215 N. 5th St., Elko, NV 89801** on **September 26, 2018.**

The claim is approximately **1500** feet in length and **600** feet in width, such that **10** feet are claimed in a **northerly** direction and **1490** feet in a **southerly** direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with **300** feet on each side of the monument of location and center line of the claim. The general course of the lode or vein, as near as it may be determined, is **northerly** to **southerly**, and it is situated in Eureka County, Nevada.

The exterior boundaries of the claim are distinctly marked by four 2" x 2" wooden posts extending at least three feet above the surface of the ground, with scribed metal tags, one at each corner of the claim, and the location monument along the centerline of the claim. The claim is more particularly described by metes and bounds as follows:

Beginning at the point of discovery (the monument of location), which is approximately **923** feet **south**, and **7374** feet **west** to a natural object or permanent monument, being the NW corner of **Section 32, T22N, R50E, M.D.M.** thence **10** feet **north** to the true point of beginning, thence **300** feet **east** to Corner 1, the NE corner of the claim, marked **SGB 47**, thence **1500** feet **south** to Corner 2, the SE corner of the claim, marked **SGB 47**, thence **600** feet **west** to Corner 3, the SW corner of the claim, marked **SGB 47**, thence **1500** feet **north** to Corner 4, the NW corner of the claim, marked **SGB 47**, thence **300** feet **east** to the true point of beginning.

The claim encompasses portions of the following quarter section(s), section(s), township(s), and range(s):

NW 1/4 of Section 33, T22N, R50E, M.D.M.
SW 1/4 of Section 28, T22N, R50E, M.D.M.

in Eureka County, State of Nevada.

The boundaries of the claim were defined as required by law within 60 days from the date of posting of the Notice of Location. The work of location consisted of making a claim map as provided in N.R.S. 517.040.
