The Claim is approximately 1500 feet long and 600 feet wide, such that 1480 feet are claimed in an East direction and 20 feet in a West direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with 300 feet on each side of the monument of location and center line of the Claim. The general course of the lode or vein is from the East to the West direction.

The number, location and markings on each corner monument are as follows:

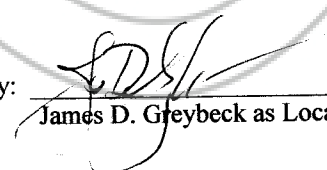

As erected on the ground, each corner monument is marked as described above by scribed metal tags.

The work of location consisted of making a claim map as provided in NRS 517.040. The tie from the claim block to a fixed point is depicted on the location map included with this filing.
