CERTIFICATE OF LOCATION
LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that the HR 97 lode mining claim has been located by Golden Pick LLC, whose current mailing address is 2215 N. 5th St., Elko, NV 89801 on January 11, 2019.

The claim is approximately 1500 feet in length and 600 feet in width, such that 10 feet are claimed in a northerly direction and 1490 feet in a southerly direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with 300 feet on each side of the monument of location and center line of the claim. The general course of the lode or vein, as near as it may be determined, is northerly to southerly, and it is situated in Eureka County, Nevada.

The exterior boundaries of the claim are distinctly marked by four 2" x 2" wooden posts extending at least three feet above the surface of the ground, with scribed metal tags, one at each corner of the claim, and the location monument along the centerline of the claim. The claim is more particularly described by metes and bounds as follows:

Beginning at the point of discovery (the monument of location), which is approximately 820 feet south, and 14880 feet east to a natural object or permanent monument, being the NW corner of Section 28, T22N, R51E, M.D.M. thence 10 feet north to the true point of beginning, thence 300 feet east to Corner 1, the NE corner of the claim, marked HR 97, thence 1500 feet south to Corner 2, the SE corner of the claim, marked HR 97, thence 600 feet west to Corner 3, the SW corner of the claim, marked HR 97, thence 1500 feet north to Corner 4, the NW corner of the claim, marked HR 97, thence 300 feet east to the true point of beginning.

The claim encompasses portions of the following quarter section(s), section(s), township(s), and range(s):

NW 1/4 of Section 25, T22N, R50E, M.D.M.

SW 1/4 of Section 24, T22N, R50E, M.D.M.

in Eureka County, State of Nevada.

The boundaries of the claim were defined as required by law within 60 days from the date of posting of the Notice of Location. The work of location consisted of making a claim map as provided in N.R.S. 517.040.
