ORDER SETTLING FIRST AND
FINAL ACCOUNTING AND
FOR FINAL DISTRIBUTION

14 The Hearing on the First and Final Accounting, and Petition for Fees and for Final
15 Distribution filed on the 28th day of January 2019 by TESSA HOLCOMB, Personal
16 Representative of the Estate of MARGARET ALICIA NUTTALL ("the Decedent"), came on
17 regularly for hearing on the 15th day of February 2019. The Court, having reviewed the
18 First and Final Accounting, and Petition for Fees and for Final Distribution, and there being
19 no opposition thereto, and GOOD CAUSE APPEARING THEREFORE, finds as follows:

- 20 1. That notice of the hearing was given in accordance with the law;
21 2. That all allegations in the First and Final Accounting, and Petition for Fees and
22 for Final Distribution are true and correct; and
23 3. That the Decedent's Estate is in a condition to be finally settled and the assets
24 thereof distributed to the devisee hereinafter named.

25 IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the First and Final
26 Accounting of the Personal Representative, and all actions taken by the Personal
27 Representative in connection therewith as set forth in the Accounting and Petition, are
28 approved and ratified.

1 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Personal
2 Representative shall pay to herself, the sum of THREE THOUSAND FIVE HUNDRED
3 SEVENTY-EIGHT DOLLARS (\$3,578.00) as and for her statutory fee for services rendered,
4 and

5 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Personal
6 Representative shall pay to the law firm of MACKEDON LAW, P.C. the sum of FIVE
7 THOUSAND FOUR HUNDRED EIGHTY-SIX DOLLARS and 73/100 (\$5,486.73) pursuant to
8 the terms of the Fee Agreement on file herein, which includes costs advanced, and

9 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the rest, residue and
10 remainder of the estate assets including the estate's interest in the real property located at
11 300 Ruby Hill Avenue, Eureka, Nevada as hereinafter described, be equally distributed
12 between TESSA HOLCOMB and RAEANN SMITH, daughters of the decedent, pursuant to the
13 Nevada Law of Intestate Succession:

14
15 Lots 4, 5, & 6 in Block 56, also all that part of Lot 10, Block 56,
16 which is particularly described as follows:

17 BEGINNING at the NW corner of Lot 10, Block 56, thence S
18 6°40' W along the Westerly boundary line of Lot 10 a
19 distance of 136.93' to a point which is identical with the
20 Westerly 20' highway right of way line, thence N 28°16' E
21 along said right of way line a distance of 71.11' to a point,
22 thence from a tangent which is the last described course,
23 curving to the right with a radius of 220' through an angle of
24 9°28'01" an arc distance of 36.35' to a point on the Westerly
25 20' highway right of way line; thence North along the
26 Easterly line of Lot 10 a distance of 10.22' to the
27 Northeasterly corner of Lot 10, thence N 65°30' W along
28 Northerly line of Lot 10 a distance of 81.22' to the NW corner
of Lot 10, the place of beginning.

25 Also, all that part of Lot 7 in Block 56, and which is
26 particularly described as follows:

27 Beginning at the SW corner of Lot 7, Block 56, thence N
28 78°12' E a distance of 51.04' to a point on the Westerly 20'
highway right of way line, a distance of 15.19' to a point on


