2. This Petition is made and based upon Chapter 159 of Nevada Revised Statutes. Pursuant to NRS Chapter 159, Petitioner alleges that she has never been convicted of a felony, has never been suspended nor disbarred from a professional practice for misconduct, does not engage in the habitual use of alcohol or controlled substances, except by prescription, has never been judicially determined to have committed abuse, neglect, exploitation, isolation or abandonment of a child, or parent or other adult, and is not incompetent or disabled. Petitioner alleges that, within the limitations established by the Protected Person's assets, she is capable of providing for the Protected Person's basic needs.

ACCESS TO PROTECTED PERSON'S ASSETS:

- 9. Petitioner does not require access to any of the Protected Person's assets or accounts, as the purpose of this Petition is to relieve the Protected Person of any liability or obligation with respect to this real estate transaction.
